EVENT GROUNDS HOUSE RULES

- Visitors to the event must comply with the provisions of these house rules. 'Event grounds' is understood to mean: the festival grounds (including the backstage area), the campsite and the car parks.
- Dutch law is in force on the event grounds. In connection with the importance of compliance with the house rules, these will also be posted in abbreviated form at the entrances and on the grounds of the event for the visitors.
- Visitors have access to the event grounds if they: are in possession of a valid ticket and <u>are at least 18 years old</u>, unless explicitly communicated otherwise by the organisation. If you are not 18 and yet have a ticket, no access will be granted. No claim can be made for any reimbursement of tickets, travel expenses and/or any other expenses incurred.
- In order to protect, among other things, the safety of visitors to the event, visitors
 must be able to identify themselves at any time on the basis of a valid ID, and they
 can be searched at any time (including inspecting bags/backpacks brought along). In
 the event of failure to cooperate with this, further access to the event grounds may
 be denied by the organisation.
- It is not permitted to bring (seating) furniture (excluding wheelchairs and scooter mobiles), refrigerated boxes and/or your own food (including lunch packages) and beverages to the event grounds. Umbrellas are also not permitted for safety reasons. Pets and other animals are not admitted (for their own sake); assistance dogs do have access. If the violation of this provision is noted by the organisation, surrender of the violating goods will be demanded. In the event of failure to cooperate with this, further access to the event grounds may be denied by the organisation. Confiscated goods will not be returned afterwards.
- Medicines, foods and liquids that are necessary due to allergy or illness may be brought in to the event grounds with a medication passport. A medication passport is available from any pharmacy, taking into account an application time of approximately 3 weeks.
- Cannisters with propellant gas and glassware are not permitted on the event grounds. Everything made of glass and/or cannisters with propellant gas will be taken.
- Visitors dressed in club clothing and/or clothing indicating membership in (a) certain group(s) may be refused.

- Film, video and professional photographic equipment (cameras with large interchangeable lenses) and drones are not permitted, unless the organisation has explicitly agreed to this in advance (e.g. for the press). Mobile phones with photo/video capabilities and normal (digital) cameras without removable lenses, selfie sticks or GoPro are permitted on the event grounds.
- Distribution of leaflets, flyers and/or trading in goods on the event grounds and in the immediate vicinity is prohibited, unless written permission has been given by the organisation.
- Persons who apparently wish to enter the event grounds under the influence of alcohol and/or drugs may be refused. A person demonstrably under influence cannot claim any reimbursement of tickets, travel expenses and/or any other expenses incurred.
- Drugs are prohibited on the event grounds. The possession and/or use of other mind altering agents (including nitrous oxide) on the event grounds is also not permitted. In the event of the use and/or possession of soft/hard drugs and/or other mindaltering agents and/or trading in soft/hard drugs and/or other mind-altering agents, the organisation reserves the right to arrest and transfer the person in question to the police without delay.
- Smoking in festival tents and other enclosed festival areas (including e-cigarettes) is
 not permitted. The organisation may be fined by the NVWA for this. If the violation of
 this provision is noted by the organisation, the demand will be made for the smoking
 materials to be immediately extinguished and the use discontinued. In the event of
 failure to cooperate with this after a warning has been given to the offender in this
 regard, the offender may be denied further access to the event grounds by the
 organisation. The offender cannot claim any reimbursement of tickets, travel
 expenses and/or any other expenses incurred.
- Visitors must respect nature and the environment. Damage to nature and the environment is not permitted. Disposing of burning smoking materials is not permitted in connection with fire hazards. Smoking materials must always be completely extinguished. If violation is noted, further access to the event grounds will be denied, and any damage will be recovered from the party causing the damage.
- All daily social norms and values apply on the event grounds. Making threats and using violence, making discriminatory remarks in word and/or gesture or sexual harassment is not acceptable. If this is noted, further access to the event grounds will be denied, and the person may be transferred to the police. Any damage will also be recovered from the party causing the damage.
- If the commission of crimes, pollution and/or destruction of equipment and the grounds is noted, further access to the event grounds will be denied, and the person may be transferred to the police. Any damage will also be recovered from the party causing the damage.

- The possession of weapons or other objects that can be used as weapons is prohibited. If the violation of this provision is noted by the organisation, surrender of the violating goods will be demanded. In the event of failure to cooperate with this, further access to the event grounds may be denied by the organisation. Confiscated goods will not be returned afterwards. If the possession of one or more (prohibited) weapons is noted, the person will be transferred to the police.
- For the safety of visitors and employees, camera surveillance will be used at the event grounds. Anyone attending the event agrees to the making of recordings. In the event of an emergency, these recordings can be shown to third parties as supporting material. Photos and video recordings are also made at the event for promotional purposes. Anyone attending the event agrees to this.
- In the event of non-compliance with our house rules, (further) access to the event grounds will be irrevocably denied, and you will be banned from the premises for one or more years. Visitors and persons who have been denied access to the event grounds on the basis of the law and/or the house rules - for whatever reason cannot claim any reimbursement of tickets and/or travel expenses.
- The dismissal of issues and cases by the government or the police, where the events took place during and/or after the event, has no influence on sanctions imposed by the organisation.
- All situations not provided for in the house rules will be decided by the organisation. Instructions of employees of the organisation or authorised, designated persons must always be followed.
- If a visitor has complaints about the way in which he or she has been treated by the organisation, he or she may contact us at any time. If necessary, the organisation will then look for a suitable solution for the problem in consultation with the visitor.
